Notes for contributors

Articles are welcome from all those who work with groups in any discipline: whether practitioners, trainers, researchers, users, or consultants. Accounts of innovations, research findings on existing practice, policy issues affecting groupwork, and discussions of conceptual developments are all relevant. Groupwork with clients, users, professional teams, or community groups fall within our range.

Length: Full length articles; normally of around 4500 words, should show the context of practice and relate this to existing knowledge. We also accept brief contributions which need focus only on the issue at hand.

Presentation: Contributions should be double spaced with wide margins and all pages numbered in three hard copies. The name(s) of the author(s) should not appear in the text. Instead, a cover sheet should be sent with the title, the name of the author(s), and a correspondence address (when possible, email address is most welcome). A summary of approximately 200 words should also be provided.

We use a modified Harvard system of referencing. References within the text should be cited by giving the author's name and year of publication, eg. (Smith, 1928). Specific page numbers should be cited after a direct quotation. Those works cited in the text (and no others) should be listed at the end of the text in alphabetical order by author's name using the journal's standard conventions:

Assessment: All articles are submitted to peer review by two assessors, and the editor takes final responsibility for the decisions that follow.
